

## About the "discounted tickets" aimed at visitors to Japan from overseas for FY 2014

JR EAST is selling discounted tickets aimed at visitors to Japan from overseas, such as "JR EAST PASS", "JR Kanto Area Pass" and "N'EX TOKYO Direct Ticket (One-way)".

From April 1, 2014, some products will be reviewed, with the aim of enhancing the reception system and information service in order that our customers from overseas can further enjoy their travels on JR EAST trains.

### 1. About the "discounted tickets" aimed at visitors to Japan from overseas

- The features of the "JR Kanto Area Pass" will be changed and its prices revised starting from April 1, 2014.
- No changes are planned for the "JR EAST PASS" and "N'EX TOKYO Direct Ticket (One-way)".

## **2. Expansion of "JR EAST Travel Service Center (Tokyo Monorail Haneda Airport International Terminal Station)" opening hours**

From April 1, 2014, the "JR EAST Travel Service Center" in the Tokyo Monorail Haneda Airport International Terminal Station will open earlier, creating a system where overseas visitors landing early in the morning can exchange or purchase rail passes as soon as they arrive in Japan.
